Schulte lawyers have collaborated to update and expand *Insider Trading Law and Compliance Answer Book 2020*, published by Practising Law Institute. The book is a guide to the breadth and scope of the insider trading laws, including all the elements for both civil and criminal liability, various defenses, possible penalties and other remedies, the current approaches taken by the SEC and the U.S. Department of Justice to insider trading violations, application of those laws in a wide variety of circumstances and the best compliance policies, procedures and practices for firms to follow in an effort to minimize the likelihood of a violation. The 2020 edition integrates recent developments, including updates on the law regarding “personal benefit” as well as legal developments concerning whether and to what extent “cryptocurrencies” or other digital assets are treated as “securities.” Although the book is largely focused on U.S. law, it includes a chapter relating to U.K. law as well on this topic. The book is organized in a question and answer format to facilitate users gaining a full understanding of the topics that are of greatest interest to them.

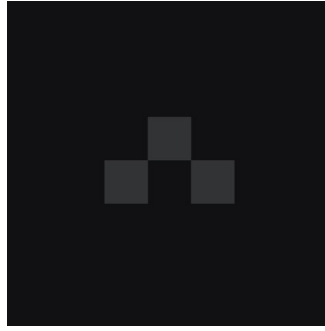
